

# Announcement of 2026 Seoul Tech Scholarship

The Seoul Metropolitan Government is pleased to announce the 2026 Seoul Tech Scholarship, designed to support outstanding students from all countries in completing master's programs at graduate schools in Seoul. The program aims to nurture talented individuals who will contribute to the city's future industries.

## 1. Overview

- ☐ **Field of Selection:** Master's programs in science and engineering (STEM) at nine universities in Seoul

- ☐ **Participating Universities (9)**

Konkuk University, Kyung Hee University, Korea University, Sogang University, Seoul National University of Science and Technology, Seoul National University, University of Seoul, Sungkyunkwan University, Soongsil University.

- ☐ **Number of Selected Students:** Approximately 30 students
- ☐ **Support Period:** Up to two years (renewable every six months after program commencement)
- ☐ **Support Details:** Full tuition coverage for the master's program (admission and tuition fees), academic incentives (living expenses, health insurance premiums, airfare)

## 2. Eligibility Requirements

- ▶ **Common Qualifications:** Applicants must meet all of the following criteria (① through ④):
- ▶ **Optional Qualifications:** For the language proficiency requirement (criterion ⑤, if applicable), refer to "Attachment 1: Admission Information for Universities."

- ① **Nationality:** Outstanding talents from all countries.  
(※ Applicants who hold Korean nationality, or whose parents hold Korean nationality, shall not be eligible.)
- ② **Age:** Under 40 years of age (born on or after January 1, 1986)
- ③ **Education:** Applicants must have earned, or be expected to earn, a bachelor's degree from a university by August 31, 2026.
- ④ **Academic Performance:** Applicants must meet one of the following criteria:
  - 1) Percentage Score: 80 or higher
  - 2) CGPA: 2.64/4.0, 2.8/4.3, 2.91/4.5, 3.23/5.0 or higher

▶ Transfer students will be evaluated based on the average of their combined grades from before and after the transfer.
- ⑤ **Language Proficiency:** Refer to "Attachment 1: Admission Information for Universities." for specific details on each university's admission criteria.

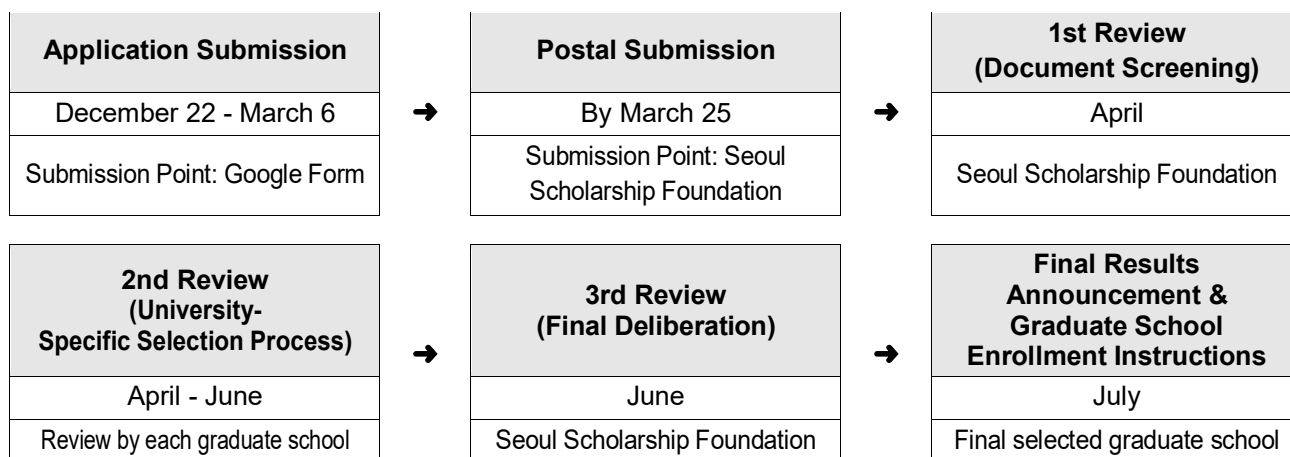
☐ **Important Notes for Document Submission**

- **Language:** All documents must be written in English or Korean.
  - ▶ For documents in a local language listed under No.2 (Supporting Documents), submit both the original document and a notarized translation. Either the original document or the notarized translation must have an Apostille. However, for Document ⑫ Other Documents, translation is required but notarization is not mandatory.
- **Document issuance date:** Only documents issued after July 1, 2025 will be accepted.
- Submitted documents will not be returned.

- All documents submitted by post must be original. Submission of copies may result in disadvantages during the evaluation process.
- Applicants are fully responsible for any disadvantages caused by errors in the submitted documents, insufficient documentation, or false information.
- If postal documents are submitted more than once, the evaluation will be based on the documents that arrive last by March 25.
- The final submission will only be accepted only when both online and postal submissions have been completed.
- Applicants may be contacted individually for additional documents required by specific graduate schools. Please refer to each school's admission information for further details.

- During the scholarship period, recipients must continue their master's coursework at their final selected graduate school.
- Scholarships will be renewed if recipients maintain full-time enrollment and achieve an average GPA of 80 or higher each semester.
- Tuition will be paid directly to the graduate school, and academic incentives will be deposited in KRW into a personal bank account opened in Korea.
- Living expenses and health insurance premiums will be disbursed after verifying the recipient's stay duration for the previous month and their insurance payment history.
- ※ Living expenses may vary depending on the duration of stay in Korea.
- Airfare for one economy-class ticket (one time) will be reimbursed upon admission to the master's program.

(1) General Assembly resolution A/73/L.40/Rev.1 adopted on 13 December 2018 decided that São Tomé and Príncipe and Solomon Islands will graduate six years after the adoption of the resolution, i.e., on 13 December 2024. Angola's graduation from the LDC category was deferred to February 2024. São Tomé and Príncipe graduated from the LDC category on 13 December 2024; the graduation of Solomon Islands was deferred to 13 December 2027 (A/RES/77/323). At the Committee for Development Policy's 2024 Triennial Review, Angola no longer met the graduation criteria from the LDC category.

(2) Guyana and Panama exceeded the high-income threshold in 2022. In accordance with the DAC rules for revision of this List. If they remain a high-income country until 2025, they will be proposed for graduation from the List in the 2026 review.

(3) The DAC agreed to defer the decision to graduate Montserrat until October 2025, based on reliable GNI per capita data to be submitted by the latest on 1 July 2025. If the data show that Montserrat remained a high-income country, it will be proposed for graduation for 2026.

(4) The DAC approved the graduation of Nauru from the DAC List of ODA Recipients but agreed to defer the date of effect of its graduation until 1 January 2026. In January 2026, the DAC will update the DAC List of ODA Recipients to reflect Nauru's graduation.

(5) Venezuela has been temporarily unclassified by the World Bank in July 2021 pending release of revised national accounts statistics. Estimated placement on the List.

Note: L, LM, UM and H shown after country names refer to the latest World Bank income classifications of: LDCs and any high-income countries that have not yet met the criteria for graduation.
